Early Voting

Early voting at neighborhood polling locations is now open for the February 26 Municipal Election. Chicago voters will be able to use any Early Voting location in the city now through February 25.

Government-issued photo ID is not required but is helpful if there is a question about the registration, address, signature or if there are two voters with the same or similar names at the same address.

Registration services are available at every Early Voting site. NOTE: Any voter who needs to register for the first time or file an address update or a name change must show two forms of ID, one of which shows the voter's current address.

NEIGHBORHOOD OPPORTUNITY FUND

Are you looking to renovate, expand or start up a business?

In 2016, Mayor Emanuel and the City Council enacted zoning reforms that generate resources from downtown development to support businesses in low-to-moderate income neighborhoods on the South, Southwest and West Sides.

Applications for project grants up to \$250,000 are now open at www.NeighborhoodOpportunityFund.com!

The application period for grants up to \$250,000 closes on March 5th. Applications for grants larger than \$250,000 are accepted on a rolling basis.

Who Can Apply?

Property owners and tenants engaged in the commercial sale of goods or services or who provide cultural experiences to the general public. We are looking for projects that will create jobs, grow local businesses, increase community wealth and provide new amenities to residents.

How Can Neighborhood Opportunity Fund Grants be Used?

For all Neighborhood Opportunity Fund projects, costs that can be funded by grants must generally be related to new construction or the rehabilitation of existing buildings. This includes:

- Land acquisition and assembly
- Building acquisition, demolition and environmental remediation
- Security measures
- Roofing, façade repair and mechanical system repairs
- Architectural and engineering fees
- Financing fees (related to securing a loan or other capital)
- Minor site improvements, such as fencing or planters, when a part of an eligible project
- Other soft costs associated with eligible hard costs
